Background and Overview

Background

- The Education Accountability Act of 2009 (SB-163, section 22-11-208 and 22-11-210 C.R.S.) requires an annual review of district and school performance.
- All districts annually receive a District Performance Framework (DPF) report. This determines their accreditation rating.
- All schools annually receive a School Performance Framework (SPF) report. This determines their school plan types.
- For districts, the Commissioner makes the final determination of the accreditation ratings. For schools, the department makes a recommendation to the State Board. Today, you will vote on the school plan types.

Purposes

- For all districts and schools, provide a statewide comparison of student performance that highlights areas of success and areas for improvement.
- Identify those districts and schools whose student performance is the lowest-performing in relation to state goals and direct state support and intervention appropriately.
- Identify those districts and schools whose students are the highest-performing, recognize them and learn from their practices.

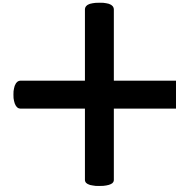

Request to Reconsider Process

Requests to Reconsider Process

- Districts had until October 16th to submit additional evidence for the Commissioner's consideration
 - CDE supported districts by reviewing drafts providing detailed feedback, along with offering individual office hours
 - 30 districts submitted draft requests for 57 schools (compared to 46 districts for 119 schools in 2016)
- Overall, CDE received:
 - 20 district requests (compared to 41 in 2016)
 - 145 school requests (compared to 239 requests in 2016)

Request to Reconsider – Recommended Approvals

- Approvals (107) and Partial Approvals (2)
 - 31 based on a body of evidence
 - Supplemental local assessment data for academic achievement, growth, and/or postsecondary and workforce readiness
 - 24 based on miscoding on the state assessment (participation calculations)
 - 12 based on request for Insufficient State Data: Low Participation
 - 40 district requested to lower the rating
 - 2 based on retroactive Alternative Education Campus designation
 - 2 schools in a small district merging into one school code

Requests to Reconsider– Recommended to Not Approve

- Not approved (36)
 - 29 based on fact that additional, supplemental data did not support a higher rating
 - 6 based on miscoding on the state assessment (participation calculations) which did not result in the school meeting the accountability participation rate calculation
 - 1 based on request for insufficient state data
 - 1 based on request for a rating for a closed school

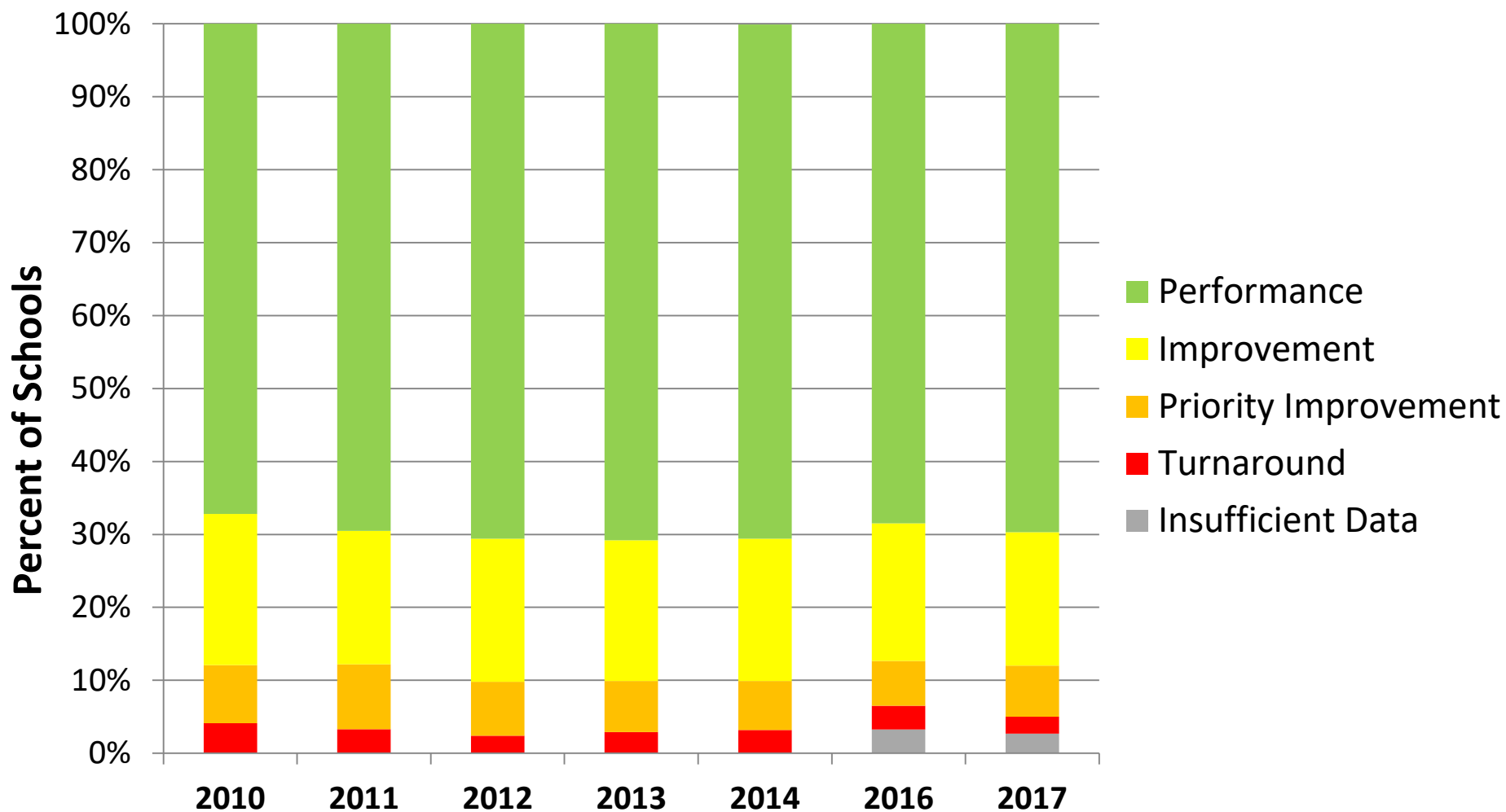

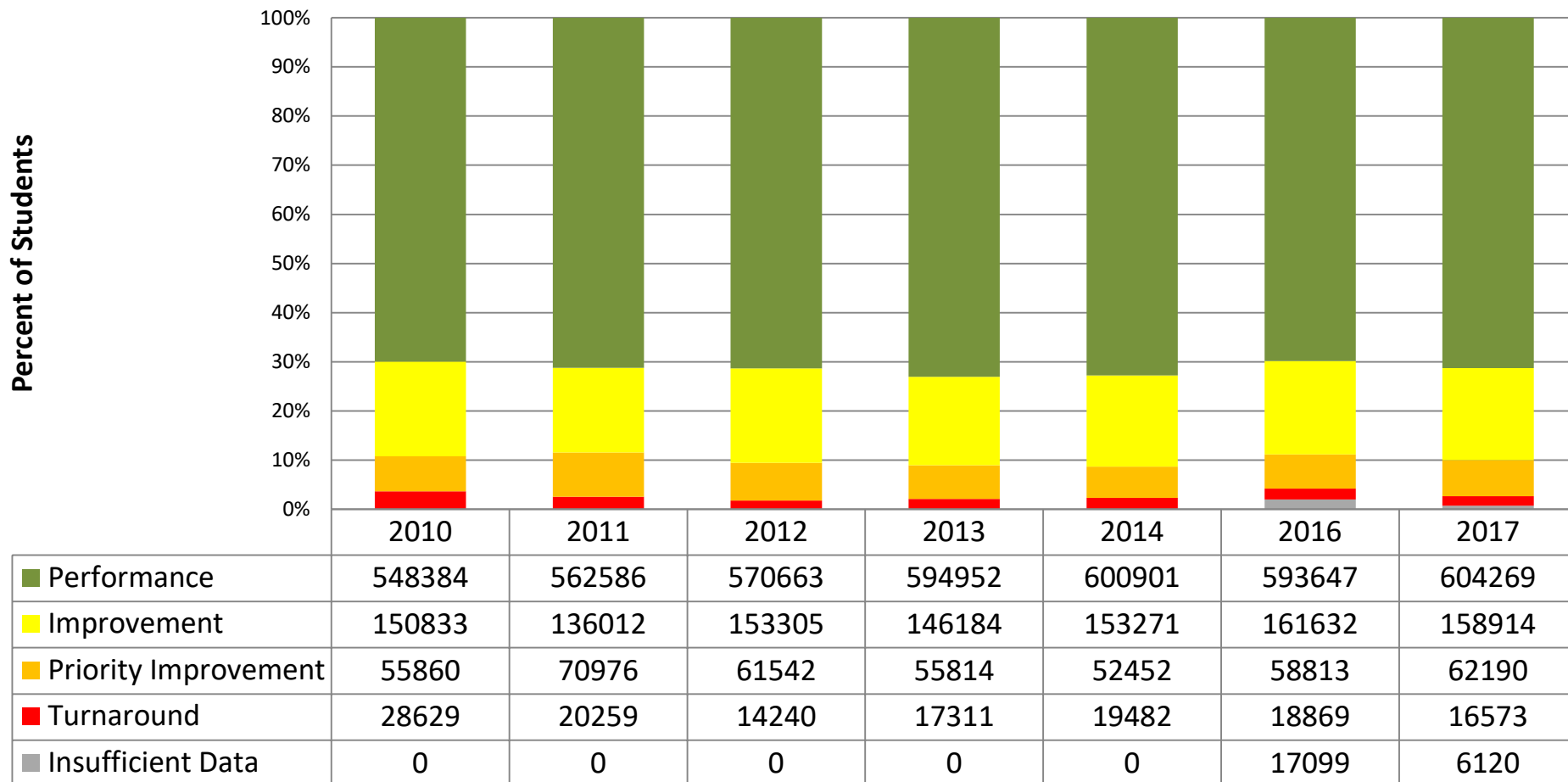

Participation Impact

- 23 schools with Insufficient State Data: Low Participation ratings
- 32 schools whose final ratings were decreased due to accountability participation rate below 95% in two or more content areas
- 525 schools receiving plan ratings with “low participation” description, due to participation rates below 95% in two or more content areas

- 67.1% of schools (1131 schools) received the same plan type in 2017 as they did in 2016.
- 14.4% of schools (245) increased at least one level (7 of those as a result of request to reconsider decisions)

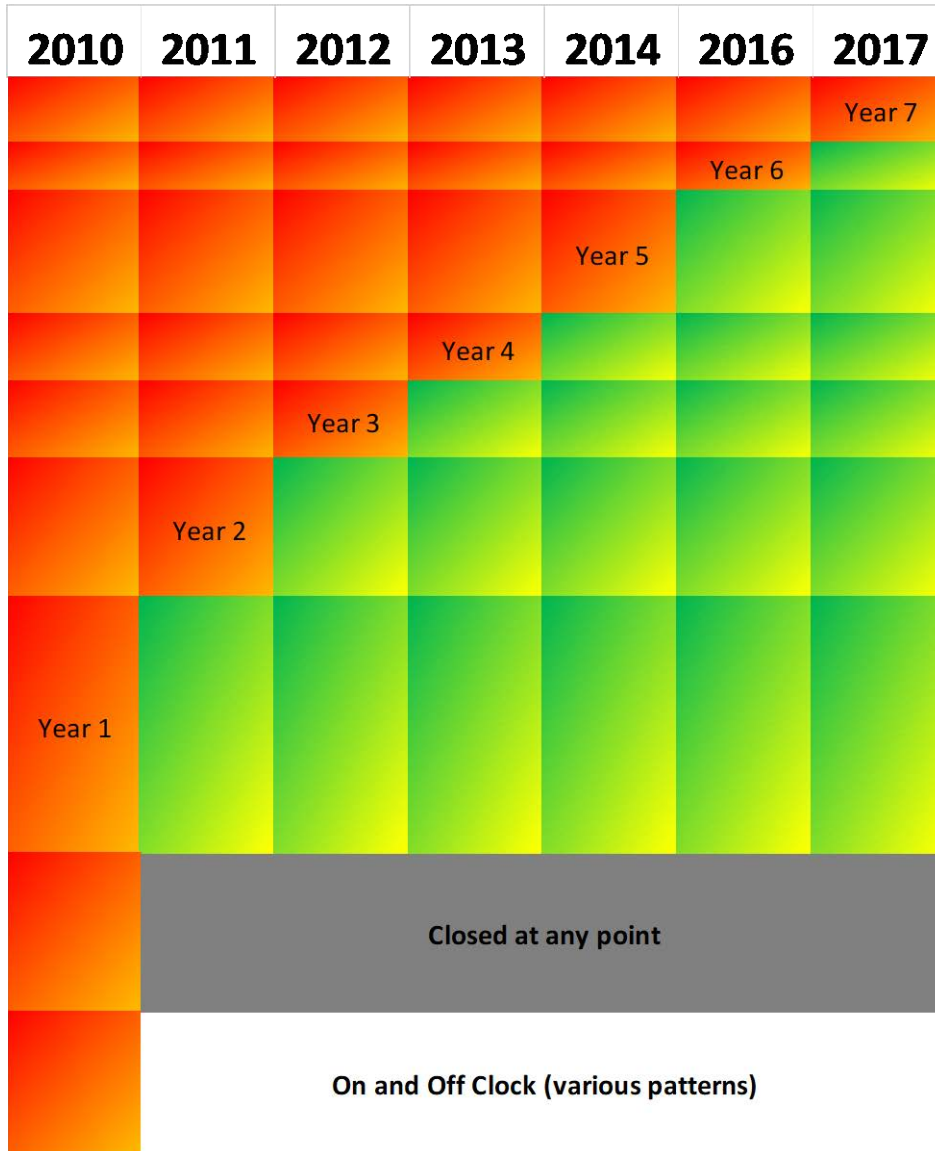
