Resources for Local Boards & Presentation Tool for Districts



Overview: Superintendents and district staff are often tasked with explaining the Colorado educational accountability system including accreditation, performance frameworks and improvement planning to locally elected Board of Education members. This information is important to support board members in providing district oversight and understanding their related statutory responsibilities. These activities include entering a district accreditation contract with the state, accrediting their schools, adopting improvement plans for the district and for state identified schools and considering improvement efforts when adopting the district' budget.

Purpose: Resources presented in this fact sheet were developed to support *Boards* of Education in better understanding state accountability and improvement plans, their statutory role and provide districts with materials to adapt and train staff around accountability metrics and improvement planning requirements and engage their local Board of Education and other stakeholders.
