**Subject:** Accountability Updates (December 11, 2024)

Hello Superintendents and Accountability Contacts –

And the countdown begins for winter break! In the meantime, we have some big accountability-related milestones to announce. Today's communication will focus on the finalization of 2024 performance frameworks, updates on accreditation contracts, and UIP feedback.

### **2024 School and District Performance Frameworks are Finalized!**

The state board voted to finalize performance frameworks today. Now that all plan types and accreditation ratings are official, the final performance framework results were be publicly posted to our [data tools](#) and the [performance framework results page](#) this afternoon. Note that the PDF reports will be linked within our [Online Performance Framework tool](#). The PDF reports will be available within the Syncplicity folder called, 'Final\_2024\_Frameworks' later this afternoon. This folder is located within the 'Performance Framework' subfolder that is contained within your main accountability folder called, 'Accountability\_Contact\_xxxx'.

### **Accreditation Contracts**

Thank you to the superintendents and local board presidents that have already signed their 2024-25 accreditation contracts. We are working with the Commissioner and State Board President to sign your contracts now and will get those posted on SchoolView soon. If your district still has not finalized signatures, please wrap this up by December 31. For superintendents in districts that participated in the request to reconsider process, contracts will be made available by December 12. As a reminder, all districts must sign annually unless eligible for automatic renewal (i.e., Districts that are Accredited or Accredited with Distinction). ### **UIP Feedback**

Feedback for improvement plans submitted in October is now available in the Online UIP System. A separate communication has been sent to UIP Contacts that provides additional details on how to access feedback. Feedback for plans reviewed by the department (i.e., Priority Improvement, Turnaround, On Watch, select ESSA Comprehensive Support Identification without

approved plans) will be released on a rolling basis. The vast majority of feedback has already been released. Sites that participated in the request to reconsider process that had their plan that were reviewed will be included in the next release. Staff will also be in touch to offer supports to leverage the feedback and strengthen improvement plans and implementation in the new calendar year.
