Executive Summary

The BEST Grant Program

In 2008, the General Assembly of the State of Colorado enacted the Building Excellent Schools Today Act, known as "BEST," in order to repair or replace unsafe, deteriorating or overcrowded public school facilities. The Colorado Department of Education's (department) Division of Capital Construction (Division) manages BEST — a competitive grant program available to all school districts, charter schools, institute charter schools, boards of cooperative educational services and the Colorado School for the Deaf and Blind.

Applications submitted every year in February are reviewed and recommended for funding by the Capital Construction Assistance Board (CCAB)—a nine-member appointed board that, in conjunction with Division staff, reviews grant applications in the spring for the following fiscal year. The State Board of Education votes in June to approve BEST awards. If any projects are recommended for funding through lease-purchase financing, the Capital Development Committee considers those requests in June. The Division works to complete condition assessments and adequacy surveys for every facility in the state every five years, with a priority to update assessments for any current grant applicants, to assist the CCAB in making informed decisions.

BEST is funded through multiple revenue sources: State Land Board proceeds, marijuana excise tax, Colorado Lottery spillover funds, and interest accrued in the Public School Capital Construction Assistance Fund. Matching funds from applicants are required by statute to receive a BEST award, and are calculated based on a series of factors, from bond election efforts over the past 10 years to assessed value per pupil.

This BEST Annual Report, which includes activities through fiscal year 2022-23, is submitted to the General Assembly pursuant to section 22-43.7-111, C.R.S.

FY 2022-23 Projects and Funding

In February of 2022, 64 applications were received, requesting \$337.8 M in grant funds¹. All requests were recommended by the CCAB, but all could not be funded, either because there was not enough cash appropriation to fund the projects or because the matching funds were not secured by the grantee. Ultimately, 41 requests were funded for a total amount of \$110.0 M. The 41 awards were all cash grants (lease-purchase financing was not available in the FY 2022-23 cycle). Including the matching funds provided by grantees, the total amount for capital construction projects was \$195.9 M.

In contrast, for the FY 2021-22 cycle, 29 projects were funded with \$138.8 M in cash grants, to support capital construction projects totaling \$260.2 M, and an additional six projects totaling \$213.9 M were financed through lease-purchase agreements. For more details, see sections 2, 3, and 6.

FY 2022-23 Facility Assessments

The Division assessed 129 public school facilities between July 1, 2022, and June 30, 2023. For each facility, the Division assesses two indicators: the Facility Condition Index (FCI), a measurement of the current condition of a facility (the higher the FCI, the poorer the condition) and the Adequacy Index (AI), a metric based on a set of questions that measure a school's compliance with set standards (the higher the score, the less the school

complies with the standards). On a scale of 0 - 1.0, the median Facility Condition Index of the schools assessed in FY 2022-23 is 0.41 and their median Adequacy Index is 0.13. For more details, see section 4.

Comparing the 40 schools with facility condition data that ranked the highest on the state Performance Framework to the 25 that scored the lowest, we found that average Facility Condition Index and average Adequacy Index were similar between the two groups. For more details, see section 5.

Capital Construction Assistance Fund

The Public School Capital Construction Assistance Fund ended the 2022-23 fiscal year with a balance of \$459.8 M and is projected to receive \$227.0 M in revenue and incur \$444.1 M in expenses during the 2023-24 fiscal year, for a projected balance of \$242.7 M by the end of June 2024. For more details, see section 7. The projected amount available to fund BEST activities in FY 2024-25 is \$179.7 M.

BEST Funded FY2022-23 Grant Projects - Summaries

Cash Projects

Widefield 3 - Watson Junior High School Boiler Replacement

This project addresses health and safety deficiencies related to two cast iron sleeved boilers in need of constant repair due to stress fractures. This project will replace the existing boilers with new high-efficiency boilers which will provide redundancy for the heating system. This project was recommended for cash funding, with the source of match being the district's capital improvement fund.

Swink 33 - Swink Campus Life Safety Upgrades

This project addresses student safety in numerous buildings on campus, replaces an outdated fire alarm system and upgrades communication between buildings. Security will be addressed with new entrance hardware, a new communication system connecting all buildings, and an updated fire alarm that will notify first responders of an incident. This project was recommended for cash funding, with the source of match being the district's capital reserve fund.

Manitou Springs 14 - Manitou Multiple Elementary School Entry Remodel/ Roof Replacement

This project addresses health and safety of students and staff by improving security and replacing leaking roofs. The security project will include a transition vestibule to allow staff visibility of visitors. The roof will be replaced along with roof top heating, ventilation, and air conditioning units. This project was recommended for cash funding, with the source of match being the district's 2022 Bond Election funds.



Julesburg RE-1 - Supplemental FY22 - PK-12 Replacement

This project addresses health and safety deficiencies including poor ventilation and temperature control, safety and supervision challenges (three separate sites), water quality and sewer issues, high radon levels, asbestos, poor insulation, and moisture intrusion. This project will resolve these deficiencies with a new energy efficient school on a site containing all district facilities. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being capital reserves.

Adams-Arapahoe 28J - Supplemental FY22 Adams-Arapahoe District Wide Fire Alarm Upgrades

This project addresses health and safety of students and staff at thirteen schools through a district-wide fire alarm upgrade. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being the district's general fund and capital reserve.

Pueblo 60 - Supplemental FY21 Sunset Elementary School Replacement

This project addresses health and safety concerns of failing mechanical, electrical and plumbing systems, and asbestos. This project will resolve these deficiencies by replacing the existing building. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being the district's general debt obligation funds.

Adams-Arapahoe 28J - North Middle School Gym Floor

This project addresses health and safety deficiencies of a gym floor that can no longer be sanded and refinished due to the depth of the wood flooring, subsurface structural issues, and asbestos in the crawl space. The asbestos will need to be abated, then structural deficiencies evaluated, then a new wood floor installed. This project was recommended for cash funding, with the source of match being the district's general fund capital reserve.

Akron R-1 - Akron PK-12 Heating, Ventilation, and Air Conditioning (HVAC) Renovations

This project addresses health and safety deficiencies including the inability to properly ventilate classrooms due to improperly functioning mechanical systems, resulting in poor indoor air quality as well as underheated and undercooled classrooms. This project will resolve these deficiencies by reworking and supplementing existing systems to bring heating, cooling, and ventilation up to current codes. This project was recommended for cash funding, with the source of match being ESSER funds and the district's capital renewal reserve funds.

Bethune - Bethune Elementary School Classroom HVAC/High School Gym HVAC

This project addresses health and safety deficiencies including a lack of ventilation and inadequate heating in the elementary school classrooms and high school gym. This project will resolve these deficiencies by introducing mechanical ventilation in the affected spaces. This project was recommended for cash funding, with the source of match being ESSER funds and the district's general fund.

Montrose County Re-1J - Multiple Elementary Schools Security Upgrades

This project addresses health and safety deficiencies including unsecure access points at four schools. This project will resolve these deficiencies by upgrading security cameras, access controls and door safety hardware as the final phase of a district side security upgrade. This project was recommended for cash funding, with the source of match being the district's capital reserve and building funds.



Fowler R-4J - Supplemental FY22 Middle School/ High School Addition-Renovation

This project addresses health and safety deficiencies including students crossing a road to access the cafeteria and sports fields, hazardous materials, and technology deficiencies. This project will resolve these deficiencies by building an addition to the existing elementary school which will include a common cafeteria and educational spaces for high school and middle school students. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being the district's general fund and/or capital reserve fund.

East Grand 2 - East Grand Middle School Roof-Fire Alarm-Boiler Replacement

This project addresses health and safety deficiencies including roof leaks, outdated fire alarm system, and a failing boiler. This project will resolve these deficiencies by replacing the roof, the fire alarm system (and adding an emergency voice/ alarm communication system), and the boiler (with a new condensing heating water boiler). This project was recommended for cash funding, with the source of match being 2021 bond funds.

Colorado Early Colleges - Colorado Springs/ High School Water Main-Restroom Improvements

This project addresses low water pressure and a multi-tenant branched sewer system that has caused numerous sewer main blockages causing the charter school to close. This has greatly impacted the student learning environment. This project will resolve these deficiencies by installing a new, accessible water main in the building which will run in the ceilings along with tankless fixtures. Restrooms will receive new walls/ ceilings and finishes. This project was recommended for cash funding, with the source of match being cash reserves.

Pueblo 60 - Supplemental FY21 Franklin Elementary School Replacement

This project addresses health and safety concerns of failing mechanical, electrical and plumbing systems, and asbestos. This project will resolve these deficiencies by building a new energy efficient school with current educational technologies and learning spaces. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being the district's general debt obligation funds.

Greeley 6 – Greeley Central High School Roof Replacement

This project addresses health and safety deficiencies including ongoing active roof leaks due to a deteriorated shrinking membrane which has begun to pull away from the walls, and faulty historic parapet coping causing damage to the masonry facades, as well as ice accumulation on adjacent sidewalks. This project will resolve these deficiencies by replacing the roof membrane, along with roof accessories and sheet metal, insulation where required, a new parapet cap to resolve the parapet coping, and repairs to the masonry facades. This project was recommended for cash funding, with the source of match being 2019 bond funds.

Alamosa RE-11J - District Wide HVAC Upgrades and Middle School Asbestos Abatement

This project addresses health and safety deficiencies including inadequate indoor air quality and asbestos containing materials. This project will resolve these deficiencies by upgrading HVAC systems to improve circulation and filtration and abate existing asbestos. This project was recommended for cash funding, with the source of match being federal Elementary and Secondary School Emergency Relief funds.



South Routt RE 3 - South Routt Elementary School and High School Geothermal HVAC Repair

This project addresses health and safety concerns for the students and staff due to the deficiencies of the exiting ground-source geothermal heat pumps and piping. Several pumps and piping need to be replaced. The piping has leaked in several locations. The district has been forced to cancel classes due to leaks in the system and the inability to properly maintain temperatures. The project will resolve these deficiencies by installing new pumps and replacing piping. This project was recommended for cash funding, with the source of match being the district's capital renewal fund.

Montrose County RE-1J - Multiple Schools HVAC Upgrades

This project addresses health and safety including poor indoor air quality and insufficient heating and cooling. This project will resolve these deficiencies by replacing outdated HVAC equipment in four schools. This project was recommended for cash funding, with the source of match being federal Elementary and Secondary School Emergency Relief funds.

Plateau RE-5 - Plateau PK-12 Addition/Renovation

This project addresses health and safety deficiencies including ventilation and air quality issues, egress safety concerns, overloaded electrical, and lack of access control and security features. This project will resolve these deficiencies by replacing the classroom wing of the school and renovating the existing athletic spaces. The project will target Collaborative for High Performance Schools Verified Leader certification. This project was recommended for cash funding, with the source of match being a November 2022 bond election.

Fremont RE-2 - Fremont Elementary School Air Quality and Ventilation Upgrades

This project addresses health and safety deficiencies including a deficient mechanical system resulting in poor indoor air quality. This project will resolve these deficiencies by installing individual unit ventilators, a building automation system, and a new chiller. This project was recommended for cash funding, with the source of match being a district federal Elementary and Secondary School Emergency Relief funds, general fund, and capital reserves.

Clear Creek RE 1 - Georgetown Community School Roof Replacement

This project addresses health deficiencies including a leaking roof and ancillary interior damage. The project will enhance student learning by replacing the existing roof and abating asbestos. The roof will have a manufacturer twenty-year warranty. This project was recommended for cash funding, with the source of match being the district's 2021 bond funds.

Monte Vista C-8 - Middle School Roof and HVAC Replacement

This project addresses health and safety deficiencies including poor indoor air quality, insufficient heating capacity, and leaking roofs. This project will resolve these deficiencies by replacing older portions of the roof that are leaking and replacing furnaces that are beyond their useful life. This project was recommended for cash funding, with the source of match being the district's general fund.

Dolores County RE-2J - Seventh Street Elementary School Replacement

This project addresses health and safety deficiencies including foundation heaving, leaking roof, inadequate plumbing fixtures, hot water distribution, exhaust, heating and cooling, intercom/phone/security systems, and fire alarm. This project will resolve these deficiencies by building a new energy efficient school. This project was recommended for cash funding, with the source of match being a 2022 bond election.



Rocky Ford R-2 - Supplemental FY22 Rocky Ford High School Renovation and PK-8 Addition

This project addresses health and safety deficiencies including mechanical and electrical deficiencies and plumbing concerns including floods. This project will resolve these deficiencies by relocating the primary and intermediate students to the high school, addressing safety concerns, and allowing for all classes to be in one location. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being the district's general fund.

Adams Arapahoe 28J - Adams Arapahoe District Wide Security Upgrades

This project addresses the safety of students by installing new access control card readers, lockdown buttons, and intrusion detection systems at twenty-three schools, as well as exterior door replacements at Pickens Technical College. This project was recommended for cash funding, with the source of match being the district's general fund and capital reserve.

Animas High School - Supplemental FY21 Animas High School Replacement

This project addresses health and safety deficiencies including inadequate electrical access, unsafe drop off/pick up and parking locations, HVAC and indoor air quality deficiencies, rodent infestation, separate buildings disconnected from communications and fire alarms, insufficient oversight of campus, and inadequate egress. This project will resolve these deficiencies through construction of a new facility on the Ft. Lewis College campus. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being the charter's construction bank loan.

Durango 9-R - Multiple Security Upgrades

This project addresses health and safety deficiencies including insecure entries. The project will resolve these deficiencies by upgrading existing entries with secure vestibules. This project was recommended for cash funding, with the source of match being the district's 2020 bond proceeds.

Burlington RE-6J - Burlington District Wide Safety/Security/Health Upgrades

This project addresses health and safety deficiencies including poor access control and supervision, asbestos abatement, and kitchen health code compliance issues. This project will resolve these deficiencies by installing an access control and camera system, replacing kitchen hoods with code compliant fire suppression and shutoff features, abating asbestos flooring, and replacing kitchen sinks and plumbing. This project was recommended for cash funding, with the source of match being federal Elementary and Secondary School Emergency Relief funds and the district's contingency reserves.

Huerfano RE-1 - Supplemental FY22 John Mall High School Replacement

This project addresses health and safety deficiencies including shifting foundations, compromised structural integrity, and inadequate HVAC systems. This project will resolve these deficiencies by constructing a new high school facility. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being the district's 2020 bond proceeds.

Cañon City RE-1 - Cañon Exploratory School HVAC Upgrades

This project addresses health and safety deficiencies including poor indoor air quality, ventilation, and circulation. This project will resolve these deficiencies by replacing rooftop units, air handlers and system controls. This project was recommended for cash funding, with the source of match being federal Elementary and Secondary School Emergency Relief funds.



Springfield RE-4 - Supplemental FY21 Springfield Addition/ Renovation

This project addresses health and safety deficiencies including nine separate school buildings creating a supervision and safety concern with students traveling between buildings. This project will resolve these deficiencies by bringing all students into the existing high school building, renovated to address lighting, HVAC, electrical upgrades, and window and roof replacement. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being the district's general fund.

Johnstown-Milliken RE-5J - Milliken Elementary School Renovation

This project addresses health and safety deficiencies including failing boilers, electrical distribution system deficiencies, a lack of access control, unrated corridors, and other outdated code compliance issues required to be updated due to the district's existing emergency ventilation and filtration grant project. This project will resolve these deficiencies by heavily renovating the interior spaces to comply with current codes, resolve access control challenges through a small addition and relocation of administration to the entrance, and replacement of temporary unrated classroom partitions with permanent rated corridors. The project will comply with the high-performance certification program in targeting Collaborative for High Performance Schools Verified Leader or equivalent certification. This project was recommended for cash funding, with the source of match being 2020 bond funds.

Liberty Common School - Elementary School Playground Safety Upgrades

This project addresses health and safety deficiencies including unsafe playground structure and inappropriate ground cover underneath the structure. This project will resolve these deficiencies by replacing the playground. This project was recommended for cash funding, with the source of match being the charter's operational budget, fundraising and other grant funds.

Fowler R-4J – High School Gym Roof Replacement

This project addresses health concerns resulting from roof leaks in the auxiliary gym which includes a stage and is used for after school activities and large assembly programs. This project will resolve these deficiencies by replacing the roof with a manufacturer's twenty-year warranty. This project was recommended for cash funding, with the source of match being the district's general fund and/or capital reserve.

Moffat County RE NO 1 - Sandrock Elementary School Security Upgrades

This project addresses safety deficiencies including lack of controlled access through the main entrance. This project will resolve these deficiencies by creating controlled access and replacing old doors and hardware. This project was recommended for cash funding, with the source of match being reserve and capital funds.

Gunnison Watershed RE1J - Crested Butte Community School Roof Replacement

This project addresses health and safety deficiencies including leaking roofs. This project will resolve these deficiencies by replacing deficient roof systems. This project was recommended for cash funding, with the source of match being the district's capital reserve fund.

<u>Vilas RE-5 - Supplemental FY22 Vilas Security HVAC Upgrades.</u>

This project addresses health and safety deficiencies by upgrading the existing mechanical system, improving access control to the main building, providing access to the second floor, and installing a new mechanical system to address temperature and air quality issues. This project will reconfigure the existing stair access and provide a lift for access to the second floor. This project was recommended for supplemental cash funding to address unprecedented cost escalation, with the source of match being the district's general fund and an energy performance contract.



Greeley 6 - Jefferson High School Roof Replacement

This project addresses health and safety deficiencies including ongoing active roof leaks due to a deteriorated shrinking membrane, parapet coping, and failed joints. This project will resolve these deficiencies by replacing the roof membrane, along with roof accessories and sheet metal, insulation where required, and a new parapet cap to seal the leaking pre-cast parapet coping. This project was recommended for cash funding, with the source of match being 2019 bond funds.

Moffat County RE-NO 1 - Moffat County High School Heating Controls and Wiring

This project addresses health deficiencies including damaged heating control wires (from a previous fire) and separate controls for the high school. This project will resolve these deficiencies by installing a new control system and wiring to allow the district control of the heating and cooling system. This project was recommended for cash funding, with the source of match being the district's reserves and capital funds.

Garfield 16 - High School and Middle School Roof Replacement/HVAC

This project addresses health and safety deficiencies including numerous roof leaks and roof top units at the high school that are beyond their service life and not providing adequate air exchanges. This project will resolve these deficiencies by replacing roofs at both schools and replacing the heating and cooling units at the high school. This project was recommended for cash funding, with the source of match being the district's capital reserve fund, a Federal Mineral Lease and federal Elementary and Secondary School Emergency Relief funds.

Mapleton 1 - Meadow Community School PK-8 School Replacement

This project addresses health, safety, and security deficiencies including site circulation, lack of secured access, cracking walls, and outdated mechanical, plumbing, and electrical systems. This project will resolve these deficiencies by building a new energy efficient school. This project is recommended for cash funding, with the source of match being a 2022 district mill levy.



Section 4 – Summary of Facility Assessment Scores Previous Cycle

Section 22-43.7-111(1)(b), C.R.S. requires the department's report to include a summary of the findings and conclusions of any public school facility inspections conducted during the prior fiscal year.

The Division assessed 129 public school facilities between July 1, 2022 and June 30, 2023.

Facility Condition Index: The Facility Condition Index (FCI) is an industry-standard measurement of the current condition of a facility. To determine FCI, the total cost of remedying deferred maintenance is divided by the current replacement value. The higher the FCI, the poorer the condition of the facility. The range among Colorado Public School facilities that were assessed in 2022-23 is 0.00-0.83 and the median is 0.41.

Adequacy Index: The Adequacy Index (AI) is a metric based on a set of questions that measure a school's compliance with set standards. The higher the score, the less the school complies with the standards. The range among Colorado Public School facilities that were assessed in 2022-23 is 0.03-0.53 and the median is 0.13.

State identified measures and metrics for each of these performance indicators are combined to arrive at an overall evaluation of a school's or a district's performance. Adequacy Index: Adequacy Index (AI) is a metric based on a set of questions that measure a school's compliance with set standards. The higher the AI the less the school complies with the standards. The range of AI among the 40 top scoring schools for which Al is available is 0.05-0.39. The range among the lowest 25 scoring schools for which data is available is 0.03-0.44
