Dear Superintendents and BOCES Executive Directors,

I hope your Thanksgiving week was restful and rejuvenating. I have a few updates for you.

Today, Gov. Polis formally announced a second round of funding for Zearn Math for the 2024-25 school year.

This innovative and data-driven digital math platform aligns to the Colorado Academic Standards and includes free high-quality instructional materials, ongoing training for educators and after-school tutoring resources for K-8 students.

The state is making this investment to bolster math skills for so many of our students who have struggled in the subject due to the pandemic and multiple years of disruptive learning experiences.

Currently, 65% of Colorado school districts and more than 920 schools have opted to use Zearn Math for the 2023-24 school year to complement their core instruction and for intervention and tutoring. While it's too early for results from Colorado schools using Zearn, we know that <u>multiple large-scale studies</u> show students who consistently used Zearn Math each week grew state math scores 2.5 times more than matched students who did not use Zearn.

While it's critical for students to catch up on missed learning, it's also just as important for students to continue moving forward with grade-level math. Zearn Math is designed to ensure all students have the opportunity to access and engage with grade-level math concepts while providing adaptive foundational support right when students need it.

That is why we are thankful that the governor has stepped up with funding for this important math accelerator that is available free to any school district that wants to use it.

CDE is asking districts, regardless of their current use, to fill out a survey about their interest in using Zearn for the 2024-25 school year.

Update on Rulemaking for School Finance and School Codes

At the next State Board of Education meeting on Wednesday, Dec. 13, the board will vote to notice rulemaking for the School Finance Rules. Based on the work of the Blended Learning Initiative, the proposed rules would expand flexibility for student learning opportunities while building appropriate guardrails. the <u>draft rules themselves</u>. After the rules are noticed in December, a hearing will be held in February. Comments are being accepted now through this <u>Google form</u>.

The board will also vote in December on proposed rules for the assignment of school codes which were noticed at the October board meeting. While codes are largely seen as administrative identifiers, the process of designating codes becomes especially important to understand when schools are closed, merged, or otherwise restructured. The proposed rules would codify the processes and policies already in place to provide transparent and predictable criteria for how codes are assigned, Stakeholder feedback was collected through Nov. 17.

Update on migrant/refugee/newcomer resources

We have heard from many of you that supporting migrating newcomer students is a growing need in your communities. CDE is establishing a series of learning cohorts for district teams to identify shared needs and share available resources. The meetings will include learning opportunities through school and district visits highlighting successful practices.
