FY 17-18 Allocation Illustration





The table below illustrates how the Colorado Department of Education (CDE) will allocate Title IV, Part A funds as required by the Every Student Succeeds Act (ESSA). This illustration has been provided to assist stakeholders in planning for FY17-18.

While the appropriations authorized under ESSA place Title IV-A at \$1.65 billion, CDE anticipates this to be a much smaller amount. For the following illustration CDE has used a \$300 million total allocation to States.

The USDE will allocate Title IV-A funds by each state's proportionate share of Title I-A. Since Colorado represents ~1.2% of the Title I-A allocation, CDE estimates that Colorado's allocation would be \$3.6 million. CDE will reserve 1% for administrative costs, 4% for state activities, and 95% for allocations to LEAs. For the purpose of this illustration the individual LEA allocations have been calculated based on the \$3.42 million distribution amount.

CDE will allocate Title IV-A funds by each LEAs proportionate share of Title I-A from the previous fiscal year. CDE will then ratably reduced these allocations so that no LEA shall have an allocation less than \$10,000. (ESSA 4105(b))

Please note that this analysis is for illustration purposes only, and not reflective of final allocations for 2017-18. These numbers will change due to final federal allocations for 2017-18, in addition to final rules and guidance for ESSA.
