





Colorado Out-of-State/Out-of-Country Process and/or Mailing Hard-copy Cards

Educator Licensing Act Only

Cardscan processing is available for those applicants residing outside of Colorado or physically unable to visit a local IdentoGo location. In order to complete the process, applicants must complete the following steps:

- 1. Obtain fingerprints on FBI (FD-258) fingerprint card from and complete the **personal information** fields on fingerprint card. *Don't worry about the 'employer', 'reason' or 'OCA' fields as that will be added once we have received your fingerprint card.* **Don't forget to include your SSN on the card.**
- 2. Pre-enroll for cardscan submission at <u>by clicking here</u> and by clicking the link titled "Submit a Fingerprint Card by Mail." You will then see the disclaimer below.
- 3. All processing fees will be collected during the pre-enrollment process. A pre-enrollment confirmation page will be provided once registration is complete.
- 4. Print and sign the completed pre-enrollment confirmation page, which includes the barcode printed on the top right of the page.
- 5. Mail the signed pre-enrollment confirmation page and the completed fingerprint card to the mailing address provided on the confirmation page printed during this pre-enrollment process.
- 6. Don't fold the fingerprint card and do not smudge the card if your prints were rolled with ink.

Disclaimer (this will show once you have selected the option to mail in your fingerprint card) All applicants are strongly encouraged to check if there is an enrollment center in close proximity that is available under the "Schedule or Manage Appointment" option. Submitting a hard card should be a last resort for either out of state applicants or home-bound applicants.

Please be aware that submission of incorrect or invalid data, including but not limited to incorrect agency fingerprint reason or applicant demographic data that results in the need to conduct a new fingerprint card submission will be at the applicant's cost. Demographic information provided on the fingerprint card must exactly match the demographic information entered during this registration process or the card will be returned.

Fingerprints submitted on hard cards are typically of lower quality and result in a higher rate of FBI rejections.

Processing of fingerprint cards takes significantly longer than fingerprinting at an enrollment center.

PRIVACY ACT STATEMENT

Authority: The FBI's acquisition, preservation, and exchange of fingerprints and associated information is generally authorized under 28 U.S.C. 534. Depending on the nature of your application, supplemental authorities include Federal statutes, State statutes pursuant to Pub. L. 92-544, Presidential Executive Orders, and federal. Providing your fingerprints and associated information is voluntary; however, failure to do so may affect completion or approval of your application.

Social Security Account Number (SSAN). Your SSAN is needed to keep records accurate because other people may have the same name and birth date. Pursuant to the Federal Privacy Act of 1974 (5 USC 552a), the requesting agency is responsible for informing you whether disclosure is mandatory or voluntary, by what statutory or other authority your SSAN is solicited, and what uses will be made of it. Executive Order 9397 also asks Federal agencies to use this number to help identify individuals in agency records.

Principal Purpose: Certain determinations, such as employment, licensing, and security clearances, may be predicated on fingerprint-based background checks. Your fingerprints and associated information/biometrics may be provided to the employing, investigating, or otherwise responsible agency, and/or the FBI for the purpose of comparing your fingerprints to other fingerprints in the FBI's Next Generation (NGI) system or its successor systems (including civil, criminal, and latent fingerprint repositories) or other available records of the employing, investigating, or otherwise responsible agency. Routine Uses: During the processing of this application and for as long thereafter as your fingerprints and associated information/biometrics are retained in NGI, your information may be disclosed pursuant to your consent, and may be disclosed without your consent as permitted by the Privacy Act of 1974 and all applicable Routine Uses as may be published at any time in the Federal Register, including the Routine Uses for the NGI system and the FBI's Blanket Routine Uses. Routine uses include, but are not limited to, disclosures to: employing, governmental or authorized non-governmental agencies responsible for employment, contracting licensing, security clearances, and other suitability determinations; local, state, tribal, or federal law enforcement agencies; criminal justice agencies;
