#### Administrative Unit Determinations - Paul Foster, Assistant Commissioner, ESSU and Orla Bolger, Special Education Data Analyst, ESSU

- IDEA requires States to make determination of the extent to which a district meets the needs of SWDs.
- Colorado is in the “Needs Assistance” category, as are most states.
- Opting out of assessments is a big issue in Colorado.
- Going forward, Colorado will continue to monitor assessments, but this will be report only; no points will be lost.
