This popular international contest encourages creators to make a tactile book prototype for young children with visual impairments. Tactile books provide a child's first, fun introduction to tactile illustrations and provides their first pleasant experiences refining their tactile skills, fine motor abilities, and exploratory skills. Children learn symbolic representations from tactile books and become acquainted with the basic conventions of tactile displays, which they will use in textbooks and other accessible, tactile resources later in life. And they learn all these things from fun books that anyone can enjoy!

Everyone is invited to enter the contest. Book prototypes must include large type, bright and contrasting color design, and engaging tactile elements that would make your book come alive for exploring fingers. The inclusion of braille is strongly recommended, and we can help you do that. We especially invite scrapbookers, illustrators, authors, all who love the book arts, and all creatives who care for young readers with blindness/visual impairment.

As the sponsor of the contest in the United States, the American Printing House for the Blind (APH) will award \$300 for First Place, \$200 for Second Place, and \$100 for Third Place. The entries will be selected by a local panel of judges. The winners of the U.S. competition will go on to the international competition.



## APH Virtual ExCEL Academy

The American Printing House for the Blind will continue to provide the APH Virtual ExCEL Academy for students in the new year. They will be offering FREE engaging lessons for students with a variety of abilities and hope to model ways that online learning may be used to supplement services. The staff of APH understands that children's needs are unique and that lessons may not apply to all kids, but they are dedicated to working out a plan to provide as much as they can. Beginning January 12, 2021, the APH Virtual ExCEL Academy will be held at 3:00 p.m. eastern time (1:00 p.m. mountain standard time) on Tuesday, Wednesday, and Thursday. The days will be grouped by age; therefore, APH will work hard to provide classes as follows:

Tuesday: Focus from birth to 6th grade.

Wednesday: Focus from 7th to 12th grade.

Thursday: Focus on students with multiple impairments.

Once a student is registered, the link remains active from **October 13, 2020 until May 27, 2021**. Because APH knows students are not always able to attend during the scheduled hour, they will be recording these sessions so all have the opportunity to learn. Many educational professionals as well as college students preparing to enter the field will be participating in the webinars to watch teachers at work. Remember, professionals are able to observe but please stay in the background just as if you were in a physical classroom. 

## APH ExCEL Camp 2021!



APH is preparing for summer! So much has happened and the Virtual ExCEL Academy held 84 Expanded Core Curriculum lessons during the school year to help supplement our students across the United States as well as to provide vision professionals ideas and give pre-service teachers an opportunity to see instruction in action. The American Printing House for the Blind (APH) is now preparing to offer the Virtual ExCEL Camp from mid-June through mid-August.

The Virtual ExCEL Camp will include a live hour at 2:00 ET, Monday through Friday, and is free to all registrants. Our target audience will continue to be students with vision loss. Also included are five at-home extension activities for the camp theme and with the camp supplies that will be sent to the student. The Virtual ExCEL Camp will be separated by age groups. We will continue to record these sessions so all have the opportunity to learn.



Please register your students with their needs and levels in mind. A grant from the Hearst Foundation is providing students from the United States of America an APH product that will be used during camp so we need registrations completed early! For students to receive items in time for camp, they must have registered for their session at least four weeks prior to the camp's start date. Those that register after that date are still welcome to attend; we would suggest working with your teacher of students with visual impairments to procure the product for use during camp as all items are available through Federal Quota.

Parents, please register your student for one camp that matches their needs. As parents, you know if they would be more appropriately placed with the age level identified. If you are unsure, we suggest reaching out to your teacher of students with visual impairments. And remember, each student must be registered separately and must meet the definition of blindness in your state.

# A Shared Vision

## A Shared Vision Update

A Shared Vision continues to be the leading provider of early intervention vision services in Colorado. Check out our numbers in our new 2020 Annual Report! (<https://www.asharedvision.org/annual-report-2020.html>) In 2020, a record 211 families received 2,141 educational service visits from our licensed Early Intervention Teachers of the Visually Impaired. The number of children served increased 6% despite the numerous challenges presented by the pandemic. We are especially pleased that the number of children we supported and the services provided in rural communities increased, 36% and 20% respectively.

We also expanded our Education program. In collaboration with the Colorado Department of Education, Paula Landry contributed to the update and electronic format design of the CDE *Vision Screening Parent Questionnaire for Children Ages Birth through Five* and developed an accompanying virtual training program. More than 800 professionals have been trained since April 2020, over half of which are qualified to use the updated tool. We also conducted briefings for the American Association of Pediatrics – Colorado Chapter and the Colorado Optometric Association on vision screening best practices and how to incorporate vision screening into well-child visits.

Because of the increasing demand for vision services, A Shared Vision is hiring! Do you love working with babies and toddlers? Are you interested in supporting little ones with blindness or visual impairments, and collaborating with other TVIs? We are looking for collaborative, sensitive, licensed teachers of the visually impaired who are interested in a flexible schedule. We will support the training and mentoring you will need to succeed in early intervention – it is different providing services to caregivers, rather than students! 

## Annual Performance Report

We just finished writing our Annual Performance Report for the Office of Special Education Programs. It has been exciting to note the project's accomplishments during the reporting period of March 1, 2020 – February 28, 2021. This is almost our exact period covering the COVID-19 pandemic. The project completed 71 milestones or key project activities / events. This is noteworthy, as we reported 35 such activities in the prior reporting period. Three of the biggest changes because of the pandemic have been CDE Office Hours, which have included specific Office Hours for BVI, DHH, and SSN. In addition the project has offered / will offer seven webinars across this school year as a means of training and support. This pivot has been key in staying attention and continuing efforts to build a statewide community of practice. And, most very exciting, has been the intervener initiatives which has involved in-depth training and support of five new interveners in Colorado school districts. Four are graduating from the SFSU program this May!



### A Letter to America's Teachers

I never could predict what might happen in Mr. O'Neil's art classes; I just knew I couldn't wait for the next assignment. Back then I didn't realize all the ways this dynamic educator, a rare man of color leading our diverse classroom of second graders, was serving as a pioneer and role model for me and my peers in John Barry Elementary School. But I'll never forget how his teaching made me feel. As a second grader, I remember looking up — watching him encourage, challenge and guide us — and thinking: "I want to be like him." In the years since embracing that calling and starting my career as a classroom teacher, I've kept that sense of purpose and wonder. And my goal in all the administrative roles I've held is to facilitate great teaching and learning: to support and expand the transformative impact that skilled, caring classroom teachers have for students, schools, and communities. Every day America's teachers change lives, and every day those lives change the world.

Now, this truth can seem to recede as you rush to keep up with the day's intense pace, and your students' needs and opportunities. Yet, from the first bell on the first day of the school year, you build a relationship with each of them. You learn their strengths and struggles, laugh with them, cry with them, worry over them, cheer for them — and at the end of the school year, help them transition to their next grade level adventure. You know all those experiences — both the academic and life lessons — have changed both you and them for the better. You empower them to grow in skill and character — expand their understanding of the world and how to shape it — explore their interests and decide where to make their mark.

Teaching is not a job anyone just falls into. It is mastery of a craft: in fact, the craft that enables all the others. In my experience, great teachers are also quintessential lifelong learners. You use your command of learning science, your insights into your students' unique needs and aptitudes, as well as the lessons of the past, the realities of the present and the inspiration, innovation and ingenuity of the future to help each new generation become leaders for today and tomorrow. Throughout the year you support your fellow educators, add to your tools through professional development, provide feedback on assignments, sponsor sports, service learning, clubs and other extracurricular activities, collaborate with parents — in addition to everything you pour into your students during class.

Even in this unprecedented year, you rallied, finding new ways to engage with students. In the face of tragedy, you learned new technologies and built virtual classroom communities, all while caring for yourselves and your own families. As we heal, recover, and rebuild, this pandemic presents a chance to forge opportunity from crisis and reimagine education on every level. We will use this time to address inequities in our education system, and your contributions will be invaluable. The work won't be easy, but the impact of your success will be profound, for students and communities. I urge state, local, and elected officials to make sure classroom teachers have a voice in your plans and efforts to reimagine education; second to parents, they know our students best.

I look forward to learning and listening from you in the days ahead. And, from all of us at the Department of Education: Happy Teacher Appreciation Week. There's a reason teacher like Mr. O'Neil — and all of you — are memorable. There's a reason student in America's classrooms watch you share your curiosity, energy and passion for ideas and think, "I want to be like them."



## State IEP System News

The Frontline contract officially extended for one year. Colorado's switch to a new online Individualized Education Program (IEP) system has a slight reprieve as the system the state has used for more than a decade will be available to schools for another year thanks to a contract extension with the previous vendor.

In March 2020 the Colorado Department of Education awarded a contract for a new IEP system to AnLar, LLC, following an extensive request for proposal process required under Colorado's Procurement Code (C.R.S. § 24-101-101) and Colorado's Department of Personnel and Administration (DPA) Rules (R-24-101-101). The previous contract with the Excent Corp. (later acquired by Frontline) had been in effect since September 2010. That contract was due to expire on June 30, 2021. However, because of the unprecedented challenges schools were facing due to the COVID-19 pandemic, CDE determined it would be a bad time to switch to a new system for many of our administrative units.

Based on feedback from the field, CDE submitted a Request for Special Circumstances Procurement to DPA's State Purchasing and Procurement Office in October 2020, requesting that CDE be allowed to enter an one-year extension with Frontline for continuity of services. DPA approved the request and CDE and Frontline began working to develop a one-year extension. Thanks to Frontline's commitment to serving the students and schools of Colorado, an agreement extending Frontline's contract with the CDE was finalized and the one-year extension is official.



## Remote Learning Option Guidance

Thanks to the hard work of CDE's School Finance, Auditing, and Office of Online and Blended Learning teams, CDE has released [remote learning options guidance for 2021-22](#) help districts prepare for the 2021-22 school year. The guidance explains flexibilities regarding remote learning and addresses instructional hours requirements and funding requirements for the 2021-22 school year.

## Equity, Diversity and Inclusion Resources



As school and district leaders work to address the learning impacts that were exacerbated by the COVID-19 pandemic, broader and newfound equity gaps will undoubtedly emerge. With this in mind, a CDE-wide, cross unit team collaborated to curate internal and external resources to assist educators in addressing these challenges. The web resource provides tools and resources to help educators bring an equity lens to their systems, policies and everyday work.

Considerations:

Apply principles of [improvement science](#) when seeking to address an inequity:

1. Make the work problem-specific and user-centered.
2. Variation in performance is the core problem to address.
3. See the system that produces the current outcomes.
4. Embed measures of key outcomes and processes to track if change is an improvement.
5. Engage rapid cycles of Plan, Do, Study, Act (PDSA) to learn fast, fail fast, and improve quickly.
6. Embrace the wisdom of crowds. We can accomplish more together than even the best of us can accomplish alone.
7. Repeat.

Apply the following [equity lens questions](#) prior to making a policy or practice change:

- Are the people most impacted meaningfully included in discussions and decisions?
- What policies or practices contribute to the exclusion?
- What are you already doing to promote inclusion?
- Who is accountable for making changes that ensure inclusion?

## Licensure Requirements for TVIs and Orientation and Mobility Specialists Colorado Initial Licensure in the Endorsement Area of Visual Impairment

For information about Colorado licensing requirements in the area of Special Education Specialist: Visual Impairment and/or School O&M Specialist, please refer to the information contained within Educator Licensing's Endorsement Requirements page at: <http://www.cde.state.co.us/cdeprof/endorsementrequirements>.

All candidates for initial educator licenses in Colorado have historically been required to take and pass one or more of the PLACE Content Assessments. Candidates for the special education endorsement in Special Education Specialist: Visual Impairment were mandated previously to pass the *PLACE Educator Content Assessment for Special Education Specialist: Severe Needs – Visually Impaired*. This particular content assessment is suspended currently as a licensure requirement. Whether this specific test will be revised to include a section specific to Unified English Braille or is fully replaced with another test as a licensure requirement is yet to be determined.

At this time, it is important to note there is not a Professional Services and Educator Licensing Unit content test that requires a candidate for the Special Education Specialist: Visual Impairment to demonstrate braille competency as a requirement of licensure. It is further important to note that if such a content test is reinstated, it does not replace the Colorado Braille Competency Test administered through the Exceptional Student Services Unit. This latter test is not tied to CDE licensure.

## Braille Competency Testing Requirements

All licensed teachers endorsed in the area of visual impairment, including those individuals employed on a temporary status (Temporary Educator Eligibility-TEE), who are completing their university program in visual impairment, must have a valid CDE Certificate of Braille Competency or a CDE Renewal Certificate of Braille Competency on file with their current administrative unit of employment. The CDE Certificate of Braille Competency must be earned no later than May 31st of the first instructional year, with a Colorado administrative unit as a teacher of students who are blind/visually impaired. If a TVI moves from one Colorado administrative unit to another, the expectation of first-year braille competency demonstration does not "reactivate" from year-to-year. The testing clock begins with the first day of Colorado employment as a TVI.

## CDE Licensure Requirement for O&M Specialists

If you are working in a Colorado administrative unit as a School Orientation and Mobility Specialist, please know that you **MUST** have a current CDE license as a Special Services Provider: School O&M Specialist. If you do not have this license, your scope of O&M services should be restricted significantly to those skills that could already be taught by a TVI. Without this license, you are placing yourself and your AU at risk for O&M-related liability. There is no temporary or emergency licenses for School O&M Specialists.

## Introduction

The Commissioner's Teacher Cabinet (CTC) is a group of practicing teachers from around the state that meets on a regular basis with the Colorado Commissioner of Education. Commissioner Katy Anthes and the Colorado Department of Education are accepting applications for eight to 10 alternating seats on the Commissioner's Teacher Cabinet.

### The goal of the CTC is threefold:

- To provide a formal opportunity for practicing teachers to ensure policy makers and legislators understand the implications of education policy;
- To provide suggestions and recommendations for the effective implementation of education policy; and
- To make policy decisions transparent to teachers. The overarching goal is to bridge the gap between policy and practice.

### In addition:

- The CTC provides feedback and suggestions to the Commissioner of Education and the Colorado Department of Education (CDE) on education policy and its implementation. This partnership gives the Commissioner and policy makers a teacher's insight to the classroom impact of education policies.
- The CTC members are practicing teachers who interact with students on a daily basis and are impacted by state education policy. They are recognized by their peers and districts as exemplary teachers who have shown strong leadership qualities in the communities
- CTC members are responsible for gathering feedback from their school communities to share, and to provide clarity of, policy initiatives to their local communities.
- As long as the cabinet exists, the term for members is two years with alternating two-year terms to ensure there are experienced members each year. Members represent diverse geographic areas, grades levels and content areas as well as diverse communities.
- The CTC is looking to have a diverse representation across the state and will make selections that enhance geographic representation.
- The CTC meets at least four times per year – in person and virtual options to meet are available.
- While no compensation or substitute reimbursement is available to members, as budget allows, CDE makes every effort to reimburse for travel and food costs associated with the in-person Cabinet meetings.
- Cabinet members receive professional development credit and a certificate and award for being selected to serve on the Commissioner's Teachers Cabinet.
- Cabinet members are often offered other opportunities across the state to serve in feedback and advisory roles.

Students will receive instruction in our four core subject areas of braille, technology, home management, and cane travel. In addition to this, we will hold workshops and activities that focus on career exploration and developing strong employment skills. These workshops include an employer panel, career interest assessment, mock interviews, and one-on-one informational interviews with professionals in your field of interest. The program will be held Monday through Thursday June 7 - June 17, 2021; we will meet on the Zoom Meeting platform from 9:00 to 11:00 a.m. and from 1:30 to 3:30 p.m. Mountain Standard Time. The cost of the program is \$1,500 and includes tuition and the materials that will be shipped to students.

**Cracking the College Code:** This two week-long virtual program is being offered to students ages 13 - 21 from across the country. Before the first day of the program, students will receive a materials box that will include a slate, stylus, braille instructional book, long white cane, sleep shades, tactile graphics, and much more. Students will receive instruction in our four core subject areas of braille, technology, home management, & cane travel. In addition to this, we will hold workshops that focus on preparing for college, student life, and participating in hands-on STEM activities. These workshops include a college student panel, hands-on chemistry project, ADA workshop, conversation with a Disability Resource Office counselor, introductory robotics lesson, and more! **No Limits to Learning:** The Colorado Center for the Blind is offering a two week-long day program to students in the Denver Metro Area between ages 13 - 21. Space is limited to 12 students and we will take applicants on a first-come first-serve basis. In this program, students will receive instruction in our four core subject areas of Braille, Technology, Home Management, & Cane Travel in a maximum of 3-to-1 student/staff ratio. On the first day of classes, students will receive a slate, stylus, Braille instructional book, long white cane, and a pair of sleep shades. We know that using non-visual skills is the most effective and efficient way for a blind person to live a successful and independent life. This is why our blind staff fully implement the Structured Discovery teaching method, which allows our students to learn through their own experiences and problem-solving techniques. In addition to the classes mentioned above, we will hold a daily philosophy class in which staff and students will discuss a variety of topics that focus on developing a positive attitude on blindness. 
### Data Release: 2018-19 National and State-Level High School Graduation Rates
