


How can we improve our systems for families and students with disabilities?





Coordinated Student Planning

- Four pilot sites move into Phase 2-Piloting the framework with students:
 - 8-12 students are identified to pilot the SOS framework:
 - Current practices, planning, assessment related to the 6 Core Student Outcomes
 - Set goals for appropriate outcomes- SOS Student Plan
 - Utilize local workbook to identify resources, services and partners
 - Coordinated student planning meetings

Coordinated Student Planning

- 1. Identify students (range of age and services needed)
- 2. Assessment related to the 6 core student outcomes
 - Build Self-Determination and Leadership Skills
 - Build Skills to Safely Navigate Community and Access Services
 - Understand Post-Secondary Options
 - Develop Competence in Computer and Digital Literacy
 - Expectation of Competitive Employment
 - Understand Disability and Health Management
- 3. Set goals related to the 6 core student outcomes
- 4. Develop a student level Sequencing of Services plan
- 5. Engage partners based on SOS workbook
- 6. Begin coordinated student planning

 Amy is 19 years old and was identified with an Intellectual Disability in first grade due to a full-scale IQ of 63 and comparable adaptive behavior.

She is currently receiving 18-21 educational services in a community-based transition program for 18–21. She is planning to continuing to receive services until she turns 21.
