


- Authorized by statute;

Colorado Department of Education's Guidance

- Written by department staff;
- No legally binding effect;
- Interprets existing legal obligations

Local School District Implementation

- Guided by local school boards;
- Elaborated by district and school leaders

K-3 Teacher Training: General Information



K-3 Teacher Training Basic Information



Beginning in 2021-22, each district that receives READ funding must ensure that all certified teachers who provide literacy instruction to students in grades K-3 have completed CDE approved evidence-based training in teaching reading.



K-3 Teacher Training District Responsibilities



Districts are responsible for:

- providing guidance and information about the training requirement to their school leaders and teachers.
- ensuring teachers complete the training by the beginning of the 2021/22 school year.
- reporting teacher completion of the evidence-based training in teaching reading.
- working with charter schools to determine how this requirement is met.

K-3 Teacher Training Timeline



- Statue states that K-3rd grade teachers must complete the evidence-based training in teaching reading by the beginning of the 2021-22 school year.
- In the September 10th State Board of Education meeting, the board affirmed its commitment to the new requirements for districts to ensure that all students have teachers who are trained in evidence-based reading instruction by the beginning of the 2021-22 school year.

K-3 Teacher Training Minimum Statute & Rule Requirements



To meet this training requirement, READ Act statute and State Board of Education rules require that the evidence-based training in teaching reading must be <u>one course</u> that fulfills this criteria:

- → Consist of a minimum of 45 hours,
- → Address the content of the Colorado Elementary Literacy Teacher standards referenced in the state board's Rules for the Administration of Educator License Endorsements, 1 CCR 301-101, section 4.02(5) through 4.02(12), and
- → Include an **end of course assessment** that teachers can provide evidence of passing.

K-3 Teacher Training Required Participants



This requirement applies to any teaching staff who provide literacy instruction to students in grades K-3, including:

- Classroom teachers
- Special Education teachers
- CLDE teachers
- Literacy Interventionists

The Rules for the Administration of the CO READ Act define **teacher**:

The professional responsible for the literacy instruction of the student(s) and may include the main instructor for a class, an instructional coach, reading interventionist, special education teacher, Title I teacher or other personnel who are identified as effective in the teaching of reading. 1 CCR 301-92 (2.36)




K-3 Teacher Training Required Participants & District Reporting



- READ ACT funds will not be released to districts until they demonstrate teacher fulfillment of this requirement.
- Districts should maintain a list of 2020-21 K-3 teachers who are responsible for literacy instruction in those grades.
- Required participants include classroom teachers, SPED, CLDE, and interventionists who provide literacy instruction to K-3 students.
- Districts will be required to submit a list of all K-3 teachers who have completed the training prior to the release of 21-22 READ Act funds.

K-3 Teacher Training Pathway Options







K-3 Teacher Training District & Teacher Responsibilities



Each pathway option on the website includes a list of responsibilities for both districts and teachers.

District Duties/Tasks	Teacher Duties/Tasks
 Districts are responsible for communicating the training requirements and fulfillment options to their teachers. Districts must keep a record of all teachers that have demonstrated fulfillment of the training requirement. 	Teachers will submit documentation of fulfillment to the Colorado Online Licensing system (COOL). • The COOL system is currently under construction • It is anticipated that documentation can be submitted to the COOL system in January 2021.

K-3 Teacher Training General FAQ



Timeline/Extension

Q: Can districts/teachers apply for an extension to fulfill this requirement?

A: CDE does not have the authority to provide flexibility with the deadline. This is the purview of the State Board of Education (SBE). The SBE **affirmed its commitment to the new requirements** for districts to ensure that all students have teachers who are trained in evidence-based reading instruction **by the beginning of the 2021-22 school year**.

K-3 Teacher Training General FAQ



Teacher Licensure

Q: Does this training requirement impact teacher licensure?

A: No, this training requirement does not impact teacher licensure. A "READ Act Designation" will be added to the license of teachers of who complete this training. Districts are responsible for ensuring that all required participants fulfill the requirement by the deadline.

Q: Can this 45-hour training be used toward re-licensure?

A: Yes.

K-3 Teacher Training Pathway Options



Option 1: CO Reading Teacher or Reading Specialist Endorsement



Option 1 Holds a State of Colorado Reading Teacher or Reading Specialist Endorsement

- Teacher receives a "READ ACT Designation" attached to his /her teacher license.
- Teacher notifies the district that he/she has met this requirement and provides district with documentation.
- Teachers do NOT need to pass any other requirement (assessment or additional training).

Option 1

Holds a State of Colorado Reading Teacher or Reading Specialist Endorsement COLORADO Department of Education

Teachers can view their license on the CDE licensing website to check for one of these endorsements.



If not clearly noted in the endorsement column, the teacher does not have the endorsement.

Option 1

Holds a State of Colorado Reading Teacher or Reading Specialist Endorsement

Reading Teacher (K-12) - 6.03 (PDF)	 Added endorsement only; must hold a valid Colorado teacher license and have two or more years of licensed teaching experience. May be earned through completion of an approved graduate program from a regionally accredited institution that shall include a supervised practicum or internship as a reading teacher.
	 Please note: Most out-of-state reading specialist programs fulfill the requirements for this endorsement. Determination of qualification for either the "reading teacher" or "reading specialist" endorsement will by made upon evaluation of application.
6.04 (PDF)	 Added endorsement only; must hold a valid Colorado teacher license and have three or more years of licensed teaching experience.
	 May be earned through completion of an approved graduate program from a regionally accredited institution for reading specialists that shall include a supervised practicum or internship as a reading specialist.
	 Please note: Most out-of-state reading specialist programs do not fulfill the requirements for this endorsement. Determination of qualification for either the "reading teacher" or "reading specialist" endorsement will by made upon evaluation of application.

Option 1 FAQ



Transcripts

Q: Can I submit my transcripts to the READ Act team to see if I have one of the endorsements?

A: No. READ Act staff do not have access to this information. Teachers should log in to elicensing to view their license and check for one of the endorsements.

Currently Enrolled in Endorsement Program

Q: I'm currently enrolled in a university program but won't graduate with the endorsement until December 2021 or later. Can I have an extension?

A: No. All current K-3 teachers must fulfill this requirement by the beginning of the 21-22 school year.

Option 1 FAQ



Additional Required Steps

Q: Do teachers with these endorsements need to submit documentation to CDE to receive the "READ Act Designation" on their license?

A: No. Teachers with these endorsements do not need to take additional action. CDE staff will add this designation to the licenses of all teachers who have these endorsements.

Designation Timeline

Q: When will this designation occur? Will teachers be notified directly?

A: An exact date is unavailable. Teachers will be notified via email when this designation is added to their license.

Option 2: State Board Approved Assessment Option Praxis 5205



Option 2 State Board Approved Assessment



The State Board of Education approved **Praxis Teaching Reading: Elementary 5205** as "one of the approved content assessment options to meet the teacher training requirement within SB 19-199."

Teachers who score at least 159 on the ETS Praxis Teaching Reading Elementary assessment (5205) will have met the evidence-based teacher training requirement established in SB-19 199.

Option 2 State Board Approved Assessment



- Teacher registers for the ETS Praxis Teaching Reading: Elementary 5205 through ETS.
 - Praxis Test Pathway Registration Support Guide
- Teacher submits evidence through the Colorado Online Licensing System of passing the PRAXIS with a score of 159 or higher.
 - Anticipated date for licensing system to accept Praxis scores: January
 2021
- Teacher receives and saves a copy of documentation from the CDE that demonstrates the "READ Act designation" attached to their CDE file.
- Teacher notifies the district that he/she has met this requirement and provides the district with documentation.

Option 2 FAQ



Praxis Cost

Q: What is the cost of this exam? Can READ funds be used to pay for the Praxis?

A: The cost of the exam is currently \$146.00 This is **not** an allowable use of READ Act funds.

Previous/Other Exam

Q: I took a Praxis/other exam several years ago, does that count?

A. No. Currently, the **only** State Board-approved exam for this purpose is the **Praxis Teaching Reading Elementary 5205 exam**, released in 2019.

Option 2 FAQ



Additional Training

Q: Are teachers who pass this specific exam required to take an additional training?

A: No. Passing this exam with a score of 159 or higher will demonstrate fulfillment of this requirement.

Q: Can I take the Praxis from home?

A: Currently, yes.

AT HOME TESTING

The <u>5205:Teaching Reading Elementary test</u> is available to take at home through ProctorU®. Candidates interested in knowing more about this option may proceed the <u>Praxis® at Home website</u>.



Option 3: Prior University Course



Option 3

Appropriate undergraduate or Graduate Course



Teachers may submit evidence of successfully completing **ONE** university course for CDE to review to determine whether it meets the statutory requirements. This must be **one course** that fulfills the following criteria:

- Documentation of 45 content hours
- Documentation that course aligns with the educator preparation literacy standards 1 CCR 301-101, section 4.02(5) through 4.02(12)
- Documentation of course completion and passing an end of course assessment

Option 3

Appropriate undergraduate or Graduate Course



Teacher duties:

- review College Course Pathway Application and complete application worksheet.
- submit all required components of the application.
- receive a certificate of approval from CDE (if approved).
- submit certificate of completion to the Colorado Online Licensing System.
- save documentation from CDE.
- notify district of fulfillment and provide district with documentation.

Option 3 FAQ



Master's Degree/Minor in Reading

Q: Will a master's degree or minor in reading fulfill the requirement?

A: The 7 options outlined in statute and rule do not include a master's degree or a minor. To fulfill this requirement, teachers must demonstrate completing **one course** that fulfills all the criteria outlined in the previous slide.

Transcripts

Q: Can I submit my transcripts to the READ Act email address to see if I need to fulfill this requirement?

A. No. CDE staff will not review transcripts for approval. Teachers seeking approval for prior coursework must complete the application steps and submit their application for review. It is important to note that a syllabus or transcripts alone will not be reviewed.

Option 4: Course Appropriate for License Renewal (Prior Training)





Teachers may submit evidence of successfully completing **ONE** prior training for the CDE to review to determine whether it meets the statutory requirements. This must be **one course** that fulfills the following criteria:

- Documentation of 45 content hours
- Documentation that course aligns with the educator preparation literacy standards 1 CCR 301-101, section 4.02(5) through 4.02(12)
- Documentation of course completion and passing an end of course assessment



Teacher duties:

- review the course application and complete application worksheet.
- submit all required components of the application.
- receive a certificate of approval from CDE (if approved).
- submit certificate of completion to the Colorado Online Licensing System.
- save documentation from CDE.
- notify district of fulfillment and provide district with documentation.



Combination of Trainings

Q: My teachers have taken a combination of different trainings over the years that we think should qualify, including instructional program-specific trainings and trainings from CDE. Do these count toward fulfillment?

A: Any prior training that teachers plan to submit for review must be <u>ONE course</u> that meets the criteria outlined on the previous slide, including evidence of passing an end of course assessment.



Q: I'm a teacher and I have completed a lot of training. Can I send a list of my trainings to the READ Act email address to see if any of them qualify?

A: No. CDE staff are not able to to review lists of trainings to determine alignment with this training requirement. Teachers are encouraged to consult with district/school leadership to understand the minimum statute requirements and determine if submitting an application for review is the appropriate choice.

Options: 5 CDE Provided Training FAQ



Training Cost

Q: Is there a cost for teachers to sign up for this training?

A: This training is provided at no cost.

READ Funds

Q: Can READ Act funds be used to compensate substitutes or pay stipends to teachers?

A: No. These are not allowable uses of READ Act funds.

Option 5 FAQ



Future Options

Q: Will these courses continue to be provided in the spring and summer of this year?

A: Yes.

Q: Will these options continue to be provided next year and moving forward?

A: CDE will continue to provide a free option to districts to support teachers in fulfillment of this requirement.

Option 6: District or BOCES-provided Training



Option 6 District or BOCES-Provided Training COLORADO Department of Education

Districts/BOCES may choose to create and provide their own professional development program to teachers to fulfill this requirement.

- The application for Districts of BOCES to submit a training for review is posted on the CDE website.
- The application is on a rolling timeline, so a District/BOCES can submit their professional development to be reviewed at any time.
- CDE will make every effort to review two applications a month beginning in August 2020.
 - All applications will be reviewed in the order they are received

Option 6 District or BOCES-Provided Training COLORADO DEPARTMENT OF EDUCATION

District Duties:

- District/BOCES completes District/BOCES PD review application and submits to the CDE for review and approval.
- Upon approval by the CDE, the district/BOCES attends a CDE webinar to learn the following:
 - scheduling and delivering the training.
 - maintaining records of teachers who participated in the training, completed the training, and passed the end of course assessment.
 - Providing a CDE-approved certificate of completion to participants.

Option 6 FAQ



Q: Have any districts submitted a professional development program for review and approval?

A: Yes, one district submitted a PD program which has been reviewed and approved for use in their district.

Option 7

Training Program from the CDE Advisory List of Professional Development



- Districts/teachers that select this option will work directly with the vendor.
- District/teacher is responsible for the cost.
- If a teacher completes this training independent of their district, there are specific tasks for the teacher to submit documentation to CDE.
- If a district sponsors a training from this list, the district will develop an approved CDE certificate of completion to provide to teachers who complete the training and pass the end of course assessment


- Districts with teachers who plan to use the LETRS 3rd Edition to fulfill this training requirement will need to submit a statement to readact@cde.state.co.us that includes the following items:
- The number of K-3 teachers engaging in this training
- The date that K-3 teachers will complete Volume 1
- The date that K-3 teachers will complete Volume 2
- Assurance that documentation will be provided to CDE that teachers have passed Volume 1 assessment with a score of 80% or higher before READ funds will be approved for the 21-22 school year
- Assurance that documentation will be provided to CDE that teachers have passed Volume 2 assessment with a score of 80% or higher before READ funds will be approved for the 22-23 school year
