## Notes for Data Pipeline Collection

Identity Management System (IdM)

#### The IdM role required to complete the report is: STU\_LEA\_Approver

Steps to complete the report in Data Pipeline

In data pipeline, the respondent will go to Discipline and then the Safety Accreditation Report.

Respondent will complete the questions and confirm the pre-populated information from the prior year is the same.

If the data pipeline user is not the same person responsible for the contents of the report, consider printing pages 2-5 of this form, completing it on paper and submitting it to the person in the district who will be entering the data in pipeline.

To complete the Pipeline Process

- 1. Log into Data Pipeline
- 2. Click on Discipline from the left-hand navigation tabs
- 3. Choose Safety Accreditation Report
- 4. Verify 2024-2025 school year and LEA, then click Search
- 5. Confirm the pre-populated information from the prior year is accurate
- 6. Update or edit the entries and then choose 1 of the 2 following options in green at the bottom of the report.

Option 1: Save and Return Later (if additional time/edits are needed)

Option 2: Save and Submit to CDE (this is the final step and submits to CDE with no further action required)
