Student Engagement Evaluation Data Collection (SEEDC) is the evaluation system that is used for collecting State Assigned Student Identifiers (SASIDs) of students served for by the Expelled and Educational Stability Grant, At-Risk Student Services Grant, Ninth Grade Success Grant, and the Student Re-Engagement Grant. This system replaced the Student Engagement Evaluation System (SEES).

Student Gender: Student's sex as recorded in RITS. 01 = Female; 02 = Male

Migrant: Students enrolled in a specially designed program for children who are, or whose parent or spouse is a migratory agricultural worker, and who, in the preceding 36 months, in order to obtain, or accompany such parent or spouse in order to obtain, temporary or seasonal employment in agricultural work has moved from one school district to another. **Only required for the Educational Stability Grant (ESG). If you are reporting on another grant program, please leave blank.**

Foster: This includes students in noncertified kinship care or in out-of-home placement.

According to Colorado Revised Statute 19-1-103, there are two types of kinship placement. The definitions are as follows:

- "Kin", for purposes of a "kinship foster care home" or for purposes of "noncertified kinship care", may be a relative of the child, a person ascribed by the family as having a family-like relationship with the child, or a person that has a prior significant relationship with the child. These relationships take into account cultural values and continuity of significant relationships with the child.
- "Noncertified kinship care" means a child is being cared for by a relative or kin who has a significant relationship with the child in circumstances when there is a safety concern by a county department and where the relative or kin has not met the foster care certification requirements for a kinship foster care home or has chosen not to pursue that certification process.

Student in out-of-home placement means a student who at any time during an academic term is in foster care and receiving educational services through a state-licensed day treatment facility, who is otherwise in placement out of the home as that term is defined in section 19-1-103 (85), C.R.S. or who is in placement outside of the home as a result of an adjudication pursuant to article 2 of title 19, C.R.S. It includes a child or youth who transfers enrollment as a result of being returned to his or her home at the conclusion of out-of-home placement. **Only required for the Educational Stability Grant (ESG). If you are reporting on another grant program, please leave blank.**

Homeless: Students in K-12 who lack a fixed, regular, and adequate primary nighttime residence and includes children and youth who are:

- Sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason;
- Living in motels, hotels, trailer parks (that are deemed as inadequate housing), or camping grounds due to the lack of alternative adequate accommodations;
- Living in emergency or transitional shelters;
- Abandoned in hospitals;
- Residing in a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings
- Living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings;
- Migratory children living in the above circumstances; and/or
- Unaccompanied youth living in the above circumstances.
