Colorado Teacher Cancellation Low Income Directory (TCLI) Eligibility Application



Section A: Loan Forgiveness Programs for Teachers

Loan forgiveness programs for teachers are intended to encourage individuals to enter and continue in the teaching profession. The Teacher Loan Forgiveness program is available to teachers who have Direct Subsidized Loans, Direct Unsubsidized Loans, Subsidized Federal Stafford Loans, and Unsubsidized Federal Stafford Loans. To be eligible, an individual must teach full-time for five (5) complete, consecutive years at an eligible school; and at least one of those years must have been after the 1997-98 school year. Certain highly qualified special education or secondary math or science teachers can qualify for up to 17,500 in forgiveness. Other eligible teachers can qualify for up to \$5,000 in forgiveness. Teachers can apply for teacher loan forgiveness after they have completed the five-year teaching requirement.

The Teacher Cancellation program is for Federal Perkins Loans only. A teacher may qualify for cancellation (discharge) up to 100% of a Federal Perkins Loan if he/she has maintained a full-time position with the district and met all contractual obligations of a public or non-public elementary or secondary school. Loan forgiveness programs are designed to dismiss all, or a portion of student loans obtained by educators.

Teacher Cancellation

The loan is cancelled in the following increments:

- 15% cancelled after the first and second year of service
- 20% cancelled for the third and fourth year of service
- 30% cancelled for the fifth year of service

Section B: Colorado School Eligibility Criteria

Every year, the USDE receives a list of eligible schools from the Colorado Department of Education which is used to update the <u>Teacher Cancellation Low Income</u> (TCLI) directory. Schools that are included in the directory must meet the following eligibility criteria:

- 1. School must be a public or other nonprofit elementary or secondary school
 - a. Non-Public schools must be nonprofit and a copy of the IRS approval for non-profit status must be included with the School Eligibility Application.
- 2. School must have 30.01+% of the school's total enrollment comprised of children who qualify as low-income. This percentage may be determined through the National School Lunch Program (NSLP) or the school may submit alternative poverty documentation such as Parent Income Survey information.
- 3. School must be located within a district that is eligible for Title I funds

Section H: Next Steps

The Teacher Cancellation Low Income (TCLI) Directory is updated for the current school year in June and December. If your school was approved for the current school year, it will be listed in the directory at that time.

Once a school is listed in the TCLI Directory, teachers in the school may fill out the <u>Teacher Loan Forgiveness Application</u> and submit the completed the application to their loan provider.

Section I: Definitions

20 U.SC. 1401(5): Educational service agency

Colorado Definitions of Public School:

- Preschool: A preschool generally serves children from birth to kindergarten eligibility age.
- Elementary School: An elementary school will generally serve children in grades K -5, but may include preschool and extend as far as 8th grade.
- Middle School: A middle (junior high) school will generally serve children in grades 6-8 but may extend beyond into typical elementary or high school grades.
- High School: A high school will generally serve children in grades 9-12. Schools which generally serve children in grades 6-12 are termed "undivided high schools."
- NOTES: For accountability purposes, Colorado assigns each school to one or more levels elementary, middle
 and/or high school. For other uses, such as Highly Qualified Teachers, Colorado attributes each school to one of
 two levels- elementary or secondary. Middle schools and high schools are considered to be secondary.

• The term "elementary school" means a nonprofit institutional day or residential school, including a public elementary charter school, that provides elementary education, as determined under **State law.**
