## Title III USDE Monitoring

- May 2005 USDE visited Colorado's Title III program and issued13 findings
- September 2010 visit, USDE issued 4 findings
  - Only one finding remained from the 2005 visit



## Title III USDE Monitoring

- September 14-17, 2010 USDE reviewed CDE's administration of the ESEA, Title III program
  - Standards, Assessment and Accountability
  - Instructional Support
  - Fiduciary



### **Pre-Site Evidence**

- 15 Major Indicators in the three areas of
  - Standards, Assessment and Accountability
  - Instructional Support
  - Fiduciary
- CDE collected and uploaded State and District level documents in July 2010 for USDE to review prior to the September visit.



## **On-Site Review**

- 15 Major Indicators in the three areas of
  - Standards, Assessment and Accountability
  - Instructional Support
  - Fiduciary
- USDE visited two school Districts
  - Aurora Public Schools
  - Jefferson County School District
- USDE spent a day and a half at CDE interviewing CDE staff and reviewing State documents



## **Post Review Findings**

- September 17, 2010 USDE held exit conference with CDE staff
  - Issued preliminary findings
  - Applauded Colorado's Title III program including application, monitoring and AMAOs
  - USDE has 30 business days to issue final Monitoring report

• Two Areas in which USDE issued findings

-Fiduciary

-Private Schools



(1)Supplement , not Supplant –ESEA, Section 3115(g)

The CDE has not ensured its Title III subgrantees meet requirements related to supplement, not supplant.

- Greater level of Review of the Title III Required Element #6 (Supplement, not Supplant) of the Consolidate Application.

(2) District Allocations, Reallocations and Carryover - ESEA, Section 3115(b)

The CDE has not ensured that its Title III subgrantees meet requirements related to the maximum percentage allowed for administrative costs. This includes all direct and indirect costs.

- 2011-2012 Consolidated application budget will have locked administrative 2% costs for Title III that include indirect and direct costs.

#### (1)Private School Participation – ESEA Section 9501(a)(1)

The CDE does not have a mechanism to collect information on the number of private school ELL students served by Title III grantees.

Consequently, the CDE cannot determine whether subgrantees have provided services to private school ELL children, their teachers and other educational personnel on an equitable basis.
