Description: In this 45-minute NCHE webinar, presenters explore the issue of doubling-up. Doubled-up is the informal wording used to describe a concept included in the McKinney-Vento Act's definition of homeless. It refers to shared living arrangements, some of which may be considered homeless, while others may not be, depending on various factors. In this session, attendees will explore some of these factors in greater detail.

Description: In this interactive NCHE webinar, presenters will review important changes related to school selection for homeless children and youth under the McKinney-Vento Act, as amended by the Every Student Succeeds Act (ESSA). Presenters will cover:

- McKinney-Vento basics and context
- The McKinney-Vento Act's definition of school of origin
- McKinney-Vento provisions related to determining the best interest of a student in terms of school selection (local school or school of origin)
- The provision of school-of-origin transportation to currently homeless students and formerly homeless students who have become permanently housed
- McKinney-Vento provisions related to dispute resolution, including disputes about school enrollment and selection
