

## McKinney-Vento and Natural Disaster Response

The devastating fires in Boulder County over the holiday break have impacted students, families, and communities across several school districts. CDE is working closely with district, state, and federal partners to ensure we are offering the support that districts need in this moment and long term. In this time, it is important to remember that children and youth who are displaced by disasters, may be eligible for support like other students in homeless situations, under the McKinney-Vento Act.

## Application Deadline for Formula Funding to Support McKinney Students Has Been Extended

The applications for the U.S. Department of Education section 2001(b)(1) of the <u>American Rescue Plan Act of 2021</u> funding to help support school districts in serving students experiencing homelessness has been **extended to March 1, 2022**.

The purposes of this funding include increasing the identification of homeless children and youth, providing wraparound services considering the impact of the COVID-19 pandemic, and providing assistance needed to enable homeless children and youth to attend school and participate fully in school activities.
