

# 2020-2021 Special Education December Count

## Purpose:

The purpose of the Special Education December Count Snapshot is to obtain data for the annual count of students with disabilities as of December 1<sup>st</sup> and the associated Staff members serving those students.

## Dependencies:

- The student has been assigned a SASID and/or LASID.
  - If a student is in a district's jurisdiction then the student will be assigned a SASID which is updated in the RITS system. The student may also be assigned a unique LASID by the district which should match the LASID reported in the Child and Participation Files.
- Special Education Students will be tracked through the Special Education IEP Interchange.
  - All special education students will have a record in a Special Education Participation file for their Admin Unit.
  - All special education students will have a record in a Special Education Child file for their Admin Unit.
- Special Education Students who are part of a district will have records in the Student Enrollment interchange.
  - All special education students who are within a district's jurisdiction will have a record in the Student Demographic file.
  - All special education students who are within a district's jurisdiction will have a record in the Student School Association file.
- Special Education staff will be tracked through the Staff Interchange by either a district or an Administrative Unit.
  - Staff Employee has been assigned an EDID and demographic data is updated in the EDIS system.
  - All special education staff will have a record in the Staff Profile File.
  - All special education staff will have a record in the Staff Assignment File.

## Criteria:

1. Criteria for Special Education **STAFF** December Count snapshot.
  - Special Education Flag = 1 in the Staff Assignment File
  - Administrative Unit Field contains valid 5 digit code in both Staff Assignment and Staff Profile Files for reporting district.
  - Start date is December 1<sup>st</sup> or prior to December 1<sup>st</sup> of reporting school year.
  - End Date is either blank (not ended) or post December 1<sup>st</sup> of the reporting school year.
  - EDID is reported in both Staff Profile and Staff Assignment Files for reporting district.
  - Records with the following Employment Status Codes will be included: 11, 12, 13, 23, 25 or 26.
  - The Staff Profile and Staff Assignment File will be joined based on the school year, EDID, sped assignment flag = 1, district or Admin Unit, and records being error free.
2. Criteria for Special Education **STUDENT** December Count snapshot.
  - In the Participation File, Date of Entry to Special Education is December 1st or prior to December 1st of the reporting school year OR Parentally Placed in Private School is 02. A record with a Date of Exit from Special Education prior to December 1st would not be included in the December Count Snapshot.

# 2020-2021 Special Education December Count

- Pull all error-free records from the Student Participation file and match them with records in the Student Profile interchange (Student Demographic file and School Association file). The Student Profile Interchange is the authoritative source for (SASID, LASID, Student's First Name, Student's Middle Name, Student's Last Name, Student's Gender, Student Date of birth, Student's Ethnicity, Student Race American Indian, Student Race Asian, Student Race Black, Student Race White, Student's Race Native Hawaiian or Other Pacific Islander, and Grade level).
- If the student is not part of a district, these fields will be pulled from the Special Education Child and Participation Files.
- Data from the Student Enrollment Interchange will pull primarily from a DEC tagged file. If the district has not tagged a file for DEC, it will pull from the untagged student file.
- The Special Education Child File, the Special Education Participation File, and the Student Profile and School Association Files will be joined based on the following criteria: SASID, LASID, school year, district (or Admin Unit), and error free records.

**Note: The primary key for the Special Education December Count Snapshot aligns with the primary key for the IEP Interchange, Student Interchange, and Staff Interchange.**

## Internal Flags

Internal flags are columns in the Special Education December Count snapshot that are derived based on other values. These fields are not updatable or viewable by the LEAs and are used to simplify edit checks and the pulling of statistics.

## FTE (Full Time Equivalency)

A calculated field based on the job class code, hours per day and contract days reported in the Staff Assignment data file. The FTE is calculated per snapshot record. Each job class code is first grouped into 22 job categories which are then used to calculate the mode hours and mode days for the district/BOCES. The mode hours and mode days for each of the job categories may be viewed in the COGNOS report “Mode Contract Days/Hours Per Day by Job Class Category” in the Human Resources data folder.

The calculation used is:

$$\frac{(Contract\ Days) \times (Hours\ per\ Day)}{(Mode\ Contract\ Days) \times (Mode\ Hours\ per\ Day)}$$
